Sir,

Please refer to your submitted bid, opened on 11.09.2024, in response to IAHE tender ref. no. IAHE/Admin./28/Hostel-Repairing/2023-24 & 2024_MoRTH_819647_1, for the work of Exterior Painting Work of IAHE Hostel & Substation at IAHE, Noida.

2. In the bid evaluation, you were declared the preferred bidder since your bid was the lowest, at 48.87% below the cost put to tender. However, considering the unusually low bid, IAHE, vide letter of even number dated 22.10.2024, requested you to submit a justification for quoting such a low bid price, along with a detailed price analysis/justification in relation to the scope, schedule, allocation of risks and responsibilities.


3. Subsequently, M/s Irfan Ahmad refused to work vide their email dated 30.10.2024, citing scaffolding, labour accommodation, and putty. This work was prestigious to IAHE, a premier training institute of the Government of India, and your refusal as the L1 bidder constitutes a breach of the code of integrity.

4. Accordingly, IAHE, vide letter dated 05.11.2024, requested you to provide a justification and explanation as to why your firm should not be debarred for two years from all future works in IAHE, to which no response has been submitted by you.

5. In view of above and para 4 of Annexure III (Form of Bid Security Deposit) of the tender document (RFP), it has been decided to debar M/s Irfan Ahmad for two years, with immediate effect, from participating in all future works of IAHE.

6. This issues with the approval of the Director, IAHE.

Please refer to your email dated 30.10.2024 in reference to IAHE letter dated 22.10.2024 requesting to submit detailed price analysis/ justification of the bid price, in which you have refused to work as per your bid submission in reference to the NIT Ref. No. IAHE/Admin/28/Hostel-Repairing/2023-24 & 2024_MoRTH_819647_1.

2. You have quoted lowest bid price for the said work. Your bid Price for the work is Rs. 20,11,015.78 [(-)48.87% of the Estimated Cost put to Tender]. However, your refusal to work is subject to strict action as per RFP.

3. Accordingly, as per the RFP page number 49, Annexure III, Para-4,
“...in case of MSME Registered firm which has taken exemption regarding deposition of Bid Security, the firm will be blacklisted and debarred for minimum of 2 years from participating in future bids of IAHE... If an Applicant withdraws its Proposal during the period of its validity as specified in this RFP...”

you are hereby requested to submit justification and explanation as to why you should not be debarred for a minimum of 2 years from all future works in IAHE within 7 days i.e. latest by 12.11.2024.
