- ii. The rate quoted should be inclusive of fixing, freight and GST etc., complete and supply should be to the site in the Campus of IAHE, A-5, Sector-62, Noida, Uttar Pradesh.
- iii. Supply should be completed as mentioned in Annexure-I within a week time after issue of the supply order.
- iv. Rates for all the items (mentioned in Annexure-I of NIQ) must be quoted by the agency in figures and words. In case of discrepancy, rate quoted in words shall prevail.
- v. Payment shall be made through NEFT/RTGS within a week time of satisfactory supply with all respect. Details of Bank A/c (name of account holder, nature of account, account number, bank name/ branch & IFSC Code) shall be specified in the quototation. Payment shall be made as per actual quantity executed at site.
- iv. In case any item is found defective in functioning, the same should be replaced with new one forthwith. Gaurantee cards should be duly filled in favour of IAHE, Noida, Sector-62 and furnished along with supply.
- 3. If any disputes arise between the successful bidder and IAHE here to or on account of interpretation of any term of this contract or otherwise due to this contract then the same may be decided by mutual consent otherwise the decision of Director, IAHE will be final and binding to the successful bidder.
