Sub: Supply of geysers to Indian Academy of Highway Engineers (IAHE) (erst while NITHE), Noida.

Your quotation may be submitted to Director in sealed envelope so as to reach by **30.01.2015, 01:00 PM** in the format as given at **Annexure-I** (in the **letter head of agency**) as per the following terms and conditions for supply of 20 (Twenty) numbers of geysers to IAHE. In the quotation, the letter number and date of this NIQ may be mentioned.

Terms & conditions

1. The Agency submitting quotation should have valid PAN and sales tax registration number. Agencies are required to submit proposals in 2 covers .The **first cover** shall contain a copy of PAN Card and sales tax registration certificate. The **second cover** shall contain the Financial Quote/ Quotation as given at Annex-1. The first cover shall be opened at first and agencies who have submitted **PAN Card and sales tax registration certificate** shall be eligible for opening of the second cover i.e. the cover containing the Financial Quote. The work shall be awarded to the firm submitting the **lowest Financial Quote**. Both the covers should be enclosed in a third cover with "Quotation for Geysers in response to IAHE's NIQ bearing no. **IAHE/Admin/05/NIQ/ 2014-15** dated **23rd January, 2015**"
2. Quotation submitted by agency should be valid upto 30 days from date of NIQ.
3. The geysers shall be of 25 litres capacity with rust proof poly propylene body with necessary safety measures, temperature adjustment provision, PUF insulation with minimum of **seven year guarantee for inner container, four year guarantee for heating element and at least two year guarantee on product** and shall be of reputed make/model (**Racold Eterno 2 of 25 litres capacity in the instant case**) . Guarantee certificate should be given by the supplier
4. The rate quoted should be inclusive of freight/ all taxes etc., complete and supply should be to the site in the Campus of IAHE (erst while NITHE), A-5, Sector-62, Noida, U.P.

5. Supply should be completed within Seven (07) days after issue of supply order.
6. Payment shall be made through cheque or NEFT/RTGS within a week of satisfactory supply of Geysers. Details of Bank A/c (name of account holder, nature of account, account number, bank name/ branch) shall be specified in the quotation.
7. In case any item is found defective on installation, the same should be replaced with new one forthwith. Gaurantee cards should be duly filled in favour of Director, IAHE, Noida, Sector-62 and furnished along with supply.
8. IAHE reserves the right to cancel the NIQ even after receipt of quotations without assigning any reason.
