**Notice Inviting Quotations (NIQ)**

Sub: Supply of Computer items to Indian Academy of Highway Engineers (IAHE), Noida.

Your quotation may be submitted to Director in sealed envelope so as to reach by 20.10.2016, 14:00 hrs in the format as given at Annexure-I (in the letter head of agency) as per the following terms and conditions for supply of Computer items to IAHE. In the quotation, the letter number and date of this NIQ may be mentioned.

## **Terms & conditions**

- 1. The Agency submitting quotation should have valid PAN and Sales tax registration number. Agencies are required to submit proposals in 2 covers. The first cover shall contain a copy of PAN Card, Sales Tax registration number and security deposit of Rs. 20,000/in the form of Demand Draft/ Bankers Cheque of a scheduled bank drawn in favour of Indian Academy of Highway Engineers payable at Noida. The second cover shall contain the Financial Quote/ Quotation as given at Annexure-I. The first cover shall be opened at first and agencies who have submitted PAN Card, Sales tax registration number and security deposit shall be eligible for opening of the second cover i.e. the cover containing the Financial Quote. The work shall be awarded to the firm submitting the lowest Financial Quote on the Grand Total basis. Both the covers should be enclosed in a third cover with "Quotation for supply of Computer items in response to IAHE's NIQ bearing no. IAHE/Admin/26/ConsumablesNIQ/ComputerItems/2015-16 dated 27th September 2016"
- 2. All the items shall be of approved brand/ make and as per sample available in IAHE (Agency may like to see the sample befor submitting the quotation) mentioned in Annexure-I of NIQ and have appropriate Guarantee/Warrantee given by manufacturer.
- 3. In the fist purchase order, quantities of procured items may vary between +25% and-25% from the quantitities mentioned in Annexure-I of NIQ.
- 4. The rates quoted shall be valid upto 31.03.2017. In case IAHE requires more quantities (maximum upto double quantities mentioned in the Annexure-I of the NIQ) during the validity period then the agency will be bound to supply additional quantities at the same rate.

- 5. The rates quoted should be inclusive of freight/all taxes etc., complete and supply should be to the site in the Campus of IAHE, A-5, Sector-62, Noida, U.P.
- 6. Supply should be completed within thirty days (30) days after issue of supply order. In case the agency fails to complete the supply with in specified period, than the security deposit is liable to be forfeited.
- 7. Rates for all the items (mentioned in Annexure-I of NIQ) must be quoted by the agency/firm. If any agency/firm fails to quote the rate of any items, his quotation shall be considered as incomplete and shall be rejected. Evaluation will be done on the basis of Grand total price. Rates must be quoted as per units (Nos, Pkts, boxes) mentioned in the quantities column at Annexure-I.
- 8. Security deposit of bidders except lowest bidder is returned in original to the bidder's not later than 15 (Fifteen) days from the date of opening of financial proposal. The security deposit of the successful firm (lowest bidder) will be released within 7 days from supply of item mentioned in the Annexure-I of NIQ.
- 9. Any bid not accompanied by security deposit and documents, as mentioned above, shall be rejected by the Academy as non-responsive.
- 10. The IAHE shall not be liable to pay any interest on the security deposit and the same shall be interest free.
- 11. Payment shall be made through cheque or NEFT/RTGS within seven days of satisfactory supply of these items. Details of Bank A/c (name of account holder, nature of account, account number, bank name/ branch) shall be specified in the quotation.
- 12. In case any item is found defective, the same should be replaced with new one forthwith.
- 13. If any disputes arise due to dealings between the successful bidder and IAHE here to or on account of interpretation of any term of this contract or otherwise due to this contract then the same may be decided by mutual consent otherwise the decision of Director, IAHE will be final and binding to the successful bidder.
- 14. IAHE reserves the right to cancel the NIQ even after receipt of quotations without assigning any reason.
- 15. Quotation shall be submitted to Director in sealed envelope superscribing "IAHE/Admin/26/ConsumablesNIQ/ComputerItems/2015-16 dated 27<sup>th</sup> September 2016"so as to reach by 20.10.2016, 14:00 hrs.
