### Notice Inviting Quotations (NIQ)

**Sub: Supply of Interactive Response System to Indian Academy of Highway Engineers (IAHE), Noida.**

Sir,

Your quotation may be submitted to Director in sealed envelope so as to reach by **17-05-2016, 01:00 PM** in the format as given at **Annexure-I** (in the **letter head of agency**) as per the following terms and conditions for supply of **Interactive Response System** to IAHE. In the quotation, the letter number and date of this NIQ may be mentioned.

### Terms & conditions

1. The Agency submitting quotation should have valid PAN and Sales tax registration number. Agencies are required to submit proposals in 2 covers. The **first cover** shall contain a copy of PAN Card and Sales tax registration and security deposit for Rs. 5000/- in the form of Demand Draft/ Bankers Cheque of a scheduled bank drawn in favour of Indian Academy of Highway Engineers payable at Noida. The **second cover** shall contain the Financial Quote/ Quotation as given at Annex-1. The first cover shall be opened at first and agencies who have submitted **PAN Card, Sales tax registration certificate & Security deposit** shall be eligible for opening of the second cover i.e. the cover containing the Financial Quote. The work shall be awarded to the firm submitting the **lowest Financial Quote (Grand total price)**. Both the covers should be enclosed in a third cover with "Quotation for supply of Interactive Response System in response to IAHE's NIQ bearing no. **IAHE/Admin/01/ETIRS/2016-17** dated **02-05-2016**"
2. Security deposit of bidders except lowest bidder is returnable in the form of a cheque or online transfer to bidder's account not later than 15 (Fifteen) days from the date of opening of financial proposal. The security deposit of the successful firm (lowest bidder) will be released within 7 days from supply of all items mentioned in the annexure I of NIQ.
3. Any bid not accompanied by security deposit, as mentioned above, shall be rejected by the academy as non - responsive.
4. The IAHE shall not be liable to pay any interest on the security deposit and the same shall be interest free.

5. All the items shall be of approved brand/ make as mentioned in Annexure-I of NIQ and have appropriate Guarantee/Warranty given by the manufacturer.
6. The rates quoted should be inclusive of freight/ all taxes etc., complete and supply should be to the site in the Campus of IAHE, A-5, Sector-62, Noida, U.P.
7. Supply of all items mentioned in annexure I should be completed within 07 (Seven) days after issue of supply order. In case the agency fails to supply all the items listed in NIQ within specified period, then the security deposit is liable to be forfeited.
8. **Rates for all the items (mentioned in Annexure-I of NIQ) must be quoted by the agency/ firm. If any agency/firm fails to quote the any item, his quotation shall be considered as incomplete and shall be rejected.** Evaluation will be done on the basis of Grand total price. Rates must be quoted as per units (Set, Nos) mentioned in quantities column at Annexure-I.
9. Payment shall be made through cheque or NEFT/RTGS within seven days of satisfactory supply of these items. Details of Bank A/c (name of account holder, nature of account, account number, bank name/ branch) shall be specified in the quotation.
10. In case supply is made in parts, part payment would be released accordingly.
11. In case any item is found defective, the same should be replaced with new one within a period of one week.
12. IAHE reserves the right to cancel the NIQ even after receipt of quotations without assigning any reason.
13. Quotation shall be submitted to Director in sealed envelope superscribing "**Quotation for supply of Interactive Response System to IAHE's NIQ bearing no. IAHE/Admin/01/ETIRS/2016-17 dated 02-05-2016**" so as to reach by 17-05-2016, 1500 hrs.
