Sir,

Please refer to your submitted bid opened on 13.06.2023 in response to IAHE tender ref no. IAHE/Admin./10/Paint-Office (B)/2022-23 & 2023_MoRTH_752732_1, for the work of Exterior Painting Work of Office Building at IAHE, Noida. In the bid evaluation, you were declared as the preferred bidder since your bid was the lowest, which was 51.1% below the cost put to tender.

2. Since the bid was very low, IAHE vide letter of even number dated 04.08.2023 asked to submit justification for quoting such low bid price and detailed price analysis/ justification of bid price in relation to scope, schedule, allocation of risks and responsibilities along with proper justification for quoting such bid price. M/s M.A. Builder had submitted the breakup of the cost of work on 14.08.2023. However, the bidder vide their email dated 19.08.2023 refused to execute the work. The above work was prestigious to IAHE (Premier Training Institute of Govt. of India) and refusal by the L-1 bidder is taken as breach of the code of integrity by IAHE.

3. Accordingly, IAHE had sent a letter to you on 30.08.2023 to submit justification and explanation as to why your firm should not be debarred for 2 years from all future works in IAHE. M/s M.A. Builder vide email dated 01.09.2023 submitted "...we were not aware the actual condition of site and my technical person wrongly put up the rates, that's why we are not able to execute the work...".

4. A Committee was constituted in IAHE to examine and submit recommendations on the above matter. After consideration of all the communications, the committee observed that since the bidder has been given opportunity for representation against debarment and their reply was not found satisfactory. Accordingly, the committee recommended that M/s M.A. Builder may be debarred for a period of one year from participating in future bids of IAHE.

5. Accordingly, Competent Authority has decided to debar M/s M.A. Builder for one year to participate in bidding from all future works of IAHE with immediate effect..

6. This issues with the approval of Director, IAHE.
